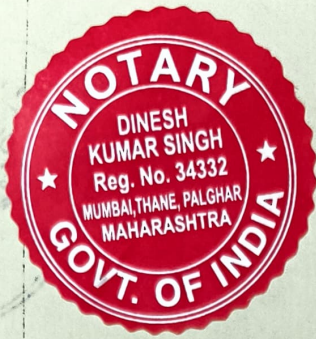

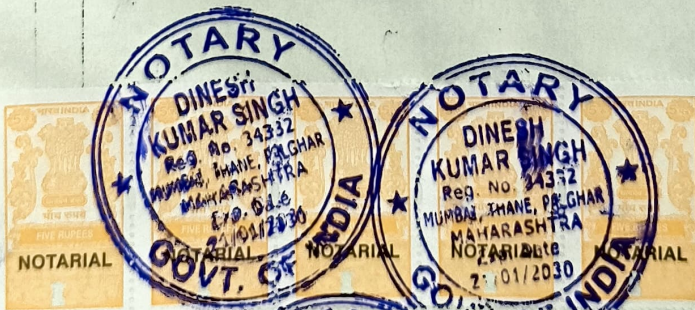

**NEW RULES AND REGULATIONS
OF**

THE NISHTHA EDUCATIONAL WELFARE SOCIETY



1. **DEFINATION:**

The word "Society" wherever mentioned means "NISHTHA EDUCATIONAL WELFARE SOCIETY".

2. **JURISDICTION:**

The jurisdiction of the society shall be entire Nallasopara/Thane.

3. **FINANCIAL YEAR:**

The financial year of the society shall be 1st April to 31st March of every year.

4. **MEMBERS AND THEIR REGISTRATION:**

The membership of NISHTHA EDUCATIONAL WELFARE SOCIETY is open to all persons, major in age. They will have to abide by the rules and regulations of the society. Every member of the society shall have to apply for membership and to pay Rs. 101/- as entrance fees. On receipt of the said entrance fees, such person shall be enrolled as the member of the society by the Managing committee. Every such member shall have to pay a sum of Rs., 25/- per month as membership fee.



5. **TYPE OF MEMBERS:**

Once a person is enrolled as the member of the society, be deemed to have been a life member unless he/she is ceased to be a member as herein provided.

6. **CEASING TO BE A MEMBER:**

A person shall ipso-facto cease to be a member and shall be removed as such by the Managing Committee

- a) On his death
- b) On his/her resignation of membership.
- c) On his/her convicted of criminal offence.
- d) If he/she fails to pay his/her subscription/monthly membership fee for more than one year.
- e) On his/her default of not attending six Consecutive meeting.

7. **GENERAL BODY MEETING :**

The annual General Body meeting of the NISHTHA EDUCATIONAL WELFARE SOCIETY shall be held once in year in the month of June at place, time and date as the Managing committee may determine.

7-A. **THE GENERAL BODY MEETING HAS FOLLOWING RIGHTS :**

- i) To elect Managing Committee of the society.
- ii) To receive and approve the statement of accounts.
- iii) To appoint office staff
- iv) To appoint Advocate as Legal Advisor.
- v) To look after and check the activities of the society.
- vi) To appoint an Accountant and Auditor.,
- vii) To consider any other matter to be brought before the meeting with the permission of the society.

B. **NOTICE OF THE GENERAL BODY MEETING AND QUORUM :**

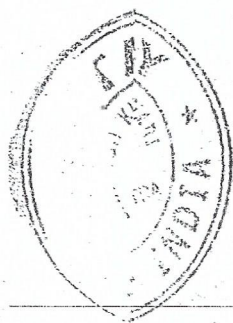
A 15 days notice shall be required to be given for meeting of the General Body Meeting. The 3/5-th members of the society shall form the quorum.

An extra ordinary General body meeting maybe conveyed by the Managing Committee of its' own motion or upon a requisition made in writing either by the President or by the 1/5th members of the society. Such requisitioners shall be subject to the meeting proposed to be cancelled and must be signed by all the requisitions and shall be delivered at the office of the society.

On receipt of the requisition of the Managing committee, Managing committee shall forthwith proceed to convey an Extra ordinary General Body meeting if the committee fails to do so, the President himself/herself. or the requisitioners themselves may convene such meeting within one month from the delivery of such requisition.

10. **MANAGING COMMITTEE:**

The Management and administration of the society shall be carried out and managed by the Managing committee under the rules and regulations of the society. The Managing committee shall be constituted of the following members :

11. **THE PERIOD OF THE MANAGING COMMITTEE AND MODE OF ELECTION:**

The Managing committee members shall held office for a period of 05 years. The election of the Managing committee members shall be done by the secret ballot paper.

OFFICE BEARERS AND THEIR JOB :

*The Managing committee shall elect from amongst its members office bearers for Five years i.e Chairman, Secretary, Treasurer and members. Their duties shall be as under :

a) **CHAIRMAN:**

The Chairman of the NISHTHA EDUCATIONAL WELFARE SOCIETY shall preside over and regulate all the meeting of the society. The President shall in addition to his/her right of voting as a member, shall be a right to vote in case of tie.

b) **SECRETARY:**

The Secretary shall accept applications for membership and submit to the Managing committee. He/She shall also maintain upto date detail list of register of members with address, age, occupation etc. He/she will maintain minute books and attend a daily routine correspondence.

c) **TREASURER:**

The Treasurer shall ordinarily receive all payments made to the society and pass the necessary receipts and shall maintain necessary books of accounts.

d) **MEMBERS:**

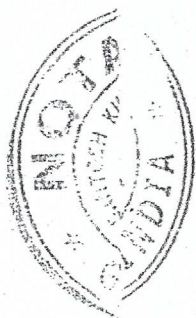
They shall attend the meetings of the society and shall give their opinion and suggestions.

13. **MEETING OF THE MANAGING COMMITTEE:**

The members of the Managing committee shall met ordinarily once in a month or more if necessary to conduct the affairs of the society,

Minimum seven days notice of meeting into writing by hand delivery shall be given to the Managing committee members.



14. **NOTICE AND QUORUM FOR THE. MANAGING COMMITTEE MEETING:**

Seven days notice in writing shall be required. to be given for commencing the Managing committee meeting either by hand delivery or under Certificate of posting. Two third member present in person shall form a quorum of the Managing committee meeting. If the meeting is adjourned for want of quorum, the same shall be held an hour latter at the same place and members present shall form the quorum. But no business other than that is specified in the notice shall be transacted in such meeting.

15. **ELECTION:**

The election of the Managing committee shall take place after every Five years in the General body meeting specifically called for.

16. **FILLING- OF THE VACANCIES :**

Any retiring members of the Managing committee shall be eligible for re-election. The casual vacancies however, may be filled by the Managing committee and such member shall hold office till the original member take her/his charges.

17. **POWERS OF THE MANAGING COMMITTEE :**

- a) To look after, manage, supervise the Management of society and its properties and spend money require for that purpose.
- b) To undertake such lawful activities, as per the rules to the attainment of the aims and objects of the society.

- c) To approach the Municipal authorities, state government or any other competent authority for lawful activities.
- d) To accept or reject new membership application.
- e) To fix date time and place of meeting of the Managing committee members and General Body meeting.
- f) To appoint legal advisor or determine their remuneration

18. **ASSETS AND SOURCES OF INCOME:**

Presently there is no assets stand in the name of the society, Membership fees, donation, monthly contribution by members shall be the main source of income.

19. **BANK OPERATION:**

The Managing committee shall open bank account in the name of the society in any schedule bank or banks or any other approved Co-Operative bank or banks and shall be operated jointly by two signature of President, Treasurer and Secretary.

20. **FUNDS AND INCOME OF THE SOCIETY OR ITS' UTILISATION:**

The funds and income of the society shall be comprise of :-

- a) All membership fees received by the committee from its members.
- b) All donations received by the society except those received by it for the specific purpose.

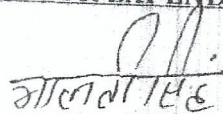
21. **UTILISATION OF THE FUNDS:**

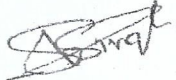

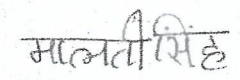
26. DISSOLUTUION:
